- I. Welcome & Call to Order | Mx. Nomura Gainor called the meeting to order at 3:32 pm.
 - **A. Invitation to Disclose Possible Conflicts of Interests** Mx. Nomura Gainor asked the Committee to disclose any possible conflicts of interest, and none were expressed.
 - **B.** Welcome New Members | Mx. Nomura Gainor welcomed the new committee members.
 - C. Approval of DEI Committee Meeting Minutes
 - 1. Mx. Nomura Gainor called for a motion to approve the October 29th meeting minutes.
 - 2. **Motion:** The motion was moved by Mr. Haroun and seconded by Ms. Kalish. With no objections, the October 29th meeting minutes were approved.
 - **D.** Overview of Meeting | Mx. Nomura Gainor gave the committee an overview of the meeting, which included deeper member introductions, DEI Survey Results, and approval of the Board of Directors Team Agreements.

II. Committee Business

- **B.** Results of DEI Surveys Discussion | Mx. Nomura Gainor gave the Committee a brief overview of the results of the DEI survey. The Committee discussed strengths and growth opportunities as well as directors' input on the annual DEI training. Mr. Peterson brought up the topic of sharing out and focusing on the DEI charter and purpose. Mr. McGovern shared how the DEI Committee and the Governance Committee could collaborate on some growth areas to further Board engagement and retention.

- **C. Team Agreements Discussion & Approval |** Mx. Nomura Gainor led the Committee in a review of the KUOW Board Agreements. The Board Agreements were designed to replace the Board Norms and were a project done in collaboration with consultant Karen Hirsch.
 - Motion: Mx. Nomura Gainor called for a motion to approve the Board Agreements and to move it to the Executive Committee for approval. The motion was moved by Mr. Warner and seconded by Mr. Peterson. With no objections, the motion was approved. With no objections, the Board Agreements will be moved to the Executive Committee for review and vote.
- D. Discussion of Engagement Opportunities with KUOW/Outside of KUOW | Ms. Robinson shared with the Committee about opportunities to engage with staff and the KUOW Racial Equity Team (RET). Mr. Warner shared concerns about intruding on staff space and trainings. Ms. Robinson shared that having Directors attend either RET meetings or staff trainings would build positive rapport and save budget.
