Hi,

Mark, I appreciate that there may be some problems you are trying to work on. I am confused about what the status is, quite honestly.

This is what I can share with you. I just completed 2 hours in the courtroom in 3C with upwards of 7 people at a time (for a sustained hour) and there is no air in the courtroom. I feel that this is a COVID/safety issue because to me the air is stagnant. It is not a question of a comfortable temperature. I am not prepared to continue to hold hearings in 3C if I am not assured that the air is moving in there and from my lay person perspective it is not moving at all. From a person who is in the courtroom physically, my report is that the airflow is not adequate. Everyone in the courtroom was aware that the air is not working correctly; it was hard going.

This is not a comfort issue. I am raising this as a safety concern. I request some information on the safety of holding hearings in that courtroom and whether the airflow is adequate. Apparently, other courtrooms have much more airflow so I am ignorant about the status of 3C but I am concerned. Since I have arrive in mid-July, there have been various issues. It was better for a while but now it is worse again. I don't feel I understand what the possible problems are and when they are a problem.

I apologize for being insistent but I am requesting more than a general status update as things move forward next week. I want to know before we hold court in there that it is safe as a matter of airflow and that it meets King County's standards for inviting the public and staff into the courtroom where we sit there for hours.

I appreciate your response. We have no in court matters this afternoon, happily.
